ACTION ITEMS

1. July Meeting Minutes:

2. Murray Hill Library

Motion: At the request of the Jacksonville Library Board of Directors, the Murray Hill Library mural is withdrawn as an Art in Public Places project. Moved by Mary Harvey. Seconded by Suzanne Pickett. Unanimously Approved.

3. San Marco / San Jose Crosswalks

Motion: At the request of Councilmember Leanna Cumber, the Art in Public Places Committee establishes the San Marco / San Jose Crosswalks in the Collaborative Projects program and approves the expenditure of up to \$7,000 for the design of intersections and crosswalks at San Marco Blvd at Nira Street and on San Jose Blvd at the Duck Pond. 4. Duval County Courthouse Plaza
