### 1. Project Updates:

#### a. Courthouse Plaza Project

- Michele D. Lee provides project updates ASP meeting has been scheduled for August 23, 2022. The ASP will review and approve the Final Design of the artwork prior to moving to fabrication.
- Cory Driscoll summarizes the need for final approval

#### b. DCPS Murals

- Followup meeting scheduled with Dr/ Kriznar in late August

#### c. KingSoutel CRA Plan (KSC)

- Proposal project options to the KSC Board Advisory Committee in late July seeking feedback on priorities and placement.
- Met with Parks dept. this week to narrow site locations.
- Developing a preliminary budget and the Call to Artist for a projection installation at COJ Park within the CRA Plan.
- Will seek final approval of the Call to Artist Draft from the KSC Board Advisory Committee prior to distribution.
- What is the APPC's role, does it have purview, will it become part of the APP Collection?
  1. CCGJ will report back to APPC in September.

#### d. San Marco Intersection Painted Mural

- Informal Bid advertised in June and Formal Bid advertised in July. Currently awaiting Vendor Award from Procurement. Contracting, timeline, and installation planning next.
- CCGJ will report back to APPC in September.

#### e. Mandarin Parks (2)

- Artists selected by ASP in May; Solomon Bassoff (Losco Park) and Greg Mueller (Rogers Park).
- Procurement closing out awards to artists. Contract negotiations began.
- Anticipating artist visits in early September.
- CCGJ will report back to APPC in September.

#### f. REI Mural at Markets at Town Center

- 2 murals on rear facade of REI store at Town Center in partnership with BigV Property Management for Markets at Town Center.
- Call to Artists launched Monday, August 8th (closes September 1st).
- Design, install occurring in September.
- Dedication in first 2 weeks of October.

#### g. Roosevelt-Edgewood Underpass

- Confirmation from FDOT that underpass construction will not commence until late 2023 early 2024. Lighting install will need to be executed after construction is completed.

- Artists selected by ASP in May; (Meg White).
- Procurement closing out awards to artists. Contract negotiations began.
- Anticipating artist visits in early September.
