### **Publicly-Funded Projects (Other):**

- Donation Proposal: Shan Shan Sheng's Obelisk from Jacksonville University
  - CCGJ Staff presents the donation proposal from Jacksonville University. Staff describes the details of materials and maintenance/conservation plan for the *Obelisk*, including the maintenance set aside

- amount of \$41,300 from the Renew Arlington Community Redevelopment Agency for the lifespan of the artwork.
- The artwork is site-specific and is located in a turbo roundabout at the intersection of University Boulevard and Merrill Road.
- The intention of this sculpture is to serve as a landmark for the Arlington neighborhood and honor its history.
- Staff clarifies that CCGJ would only be accepting the *Obelisk* artwork and not the lighting or landscaping that surrounds the piece as it was not part of the artwork budget.

## **Project Updates**

# **Publicly-Funded Projects (APP Trust):**

- Courthouse Plaza Project
  - CCGJ Staff provides an overview of the Courthouse Plaza Project, including the budget allocation, admin allocation and maintenance set aside.
  - CCGJ Staff reminds the APPC of the artist selection process in 2020.
  - Staff presents the Courthouse Plaza Design Proposal.
  - The signed Resolution (which includes an exhibit of the text central to the artwork) that was approved by the Artwork Selection Panel was presented and discussed. The word "Equity" has been changed to "Truth" and the poet Ebony Payne-English (Subcontracted Poet of Cliff Garten Studios/Commissioned Artist) provided a new poem for the Freedom panel, which the ASP unanimously approved.
  - Staff presents the proposed sculpture materials as well as maintenance and conservation plans provided by the artist.
  - Staff goes over the current project schedule, but notes it will be dependent on when the artist goes under this next contract, which is currently in contract negotiation between counsels.

### ACTION ITEM - VOTING, Approval of the Final Design Package for The Duval County Courthouse Plaza Art Project

**Motion:** The Art in Public Places Committee approves the Final Initial Design Proposal for artwork titled *These Truths: Voices Of Jacksonville* for The Duval County Courthouse Plaza Art Project per the associated Artwork Selection Panel resolution, which provides the Executive Director of the Cultural Council with the authority to administratively correct typographical errors to the project text and minor structural changes to the artwork upon final engineering. ### 2. Publicly-Funded Projects (Other)

- King-Soutel Crossing CRA Digital Installation Project
  - This will be a temporary public art project on the exterior of the Legends Community Center with a life expectancy of 3 years.
  - The KSC-CRA committee increased the grant funding to the Cultural Council to fund site amenities that will support the digital projection.
  - The total grant amount is not to exceed \$120,000.
  - CCGJ provided the recommended Art Selection Panel candidates and qualifications.

- Winged Victory, sculpture located at Winton Drive Traffic Triangle
  - The lighting repairs are completed.
- Song of the Skinks, sculpture located at Cuba Hunter Park
  - CCGJ Staff gives an update on the conservation and maintenance for Song of the Skinks. Staff was
    notified shortly before Hurricane Idalia that portions of the artwork were no longer secure. Staff
    anchored components onto the pavement prior to the hurricane making landfall.
  - CCGJ will be re-engaging with the artist to best scope the ongoing maintenance to ensure the longevity of this well loved public art piece.
