### Kimberly Kim moderated and open up Q&A:

<u>Chris Flagg:</u> Spoke of the entire vision presented and its value. The introduction of the estuaries into the landscape design as a "whole" was interesting. - Chris had 2 questions for them:

- 1- "What do you think is the strength of Phase 1 on its own? He questioned the strength of the design of phase one without the support of the entire concept.
  - 2 "Do you feel your concept can work if Monroe road is built?

Matt Neibuhr response was that they "were inspired by the introduction of scale and contrast." By inviting Nature into the space they were setting up a moment to engage with the civic space" - "The ART PIECES are planned (to be placed in the ART PLAZA) outside Monroe street Right Of Way - The goal is to

integrate the ART into the entire landscape with the possible expansion of landscaped areas... and they were open to adjust the design to accommodate Monroe St.

<u>Caitlin Doherty:</u> Mentioned she enjoyed the incorporation of Nature in the space, and that Mico Fuentes' guidance and to speak of the River and estuaries as a big part of the region was "spot on"

Caitlin also asked them (on Chris' point about Phase 1) to explain their budget and how it would be distributed for each phase in their proposal.

Matt Neiburh (artist): Explained the phase 1 was part of the area they defined as ART PLAZA. (see presentation slides)

The \$500,000 would cover: design, engineering, lighting of the columns for the Art Forms. However, paving the area, creating the land asmr in that section and adding area lighting would be a different line item at about \$56,000

Landscape outside of the ART PLAZA would evolve with urban growth happening around it at an estimated cost of \$1.7 million. With the final product having an accumulative figure of almost \$2.5 million

<u>David Dahlquist (artis)</u> talked about their interpretation of Nature as the perfect element for this site. He mentioned a comparison with the "tides" and how it can be associated with "justice" as when the water comes in and "washes everything away". Nature associated with Biodiversity - Nature inviting people into the space.

<u>Caitlin</u> said she understood the constant rhythm created by the tides and the comparison with "human nature polarity" and in this case, "of nature softening the urban rhythm"

Bryant Rollins brought up the "important difference in the perception of nature by different cultures." He asked if the designing team had thought about the strong african american community present and prevalent in the history of that area of Jacksonville. He wanted to know if they had considered that the "perception of neutrality" given by nature and more specifically, by trees, could have completely different interpretations when experienced by African Americans. Bryant said: the "Neutrality you speak off would need to be emphasized"

Matt spoke about wanting to have community engagement as they develop the concept further and that, through that dialogue they could create "the sensibility" (Bryant mentioned) into the "Nature Theme"

There were no more comments after that and Kimberly Kim asked Hilda for comments from the public.
