Call to Order

The meeting was brought to order by Lisa Moore at 8:37 a.m. with a quorum present.

Review and Approval to Minutes

Finance Department Updates and Report from Essential Bookkeeping Solutions (EBS)

Ms. Brady of Essential Bookkeeping Solutions, (EBS), reported that they have reviewed the financials, and that it does not agree with the draft audit. The income does agree to the expenses. The executive director and the director of public art have reviewed and come to this

same conclusion as well. EBS has reached out to the auditor to ask what document the auditor is drawing the numbers from, to adjust the audit, and ask additional questions. It continues to be clear there are discrepancies between the audit and reports; more work needs to be done to bring resolution.

Lisa Moore asked there to be proposal options for auditors; there should be 2-3 proposals every few years. She would like proposals for auditors and payroll services.

2019-2020 Draft Budget

Dawn Brady from Essential Bookkeeping Solutions has provided a restructured budget. Jannet Walker Ford asked for further discussion to clarify the numbers from the budget report. The executive director spoke through each line item on the budget. The committee spoke to increase the marketing budget and offset expenses for lunches and travel. Jannet Walker Ford recommended to include a contingency fund.

The executive director spoke to doing a broader economic impact study and bringing in Americans for the Arts. Lisa Moore would like a chart for progress.

Lisa Moore made a motion to approve the draft budget with edits, Ann Carey seconded the motion.
